### Mission

To build a more equitable, healthy Maine by deepening the connection of all people to the arts and nature.

#### History

Susan and Fritz Onion formed the Foundation in 2014.

Susan and Fritz chose to work on the arts and the environment because both areas bring their family joy and fulfillment.

To date, the Foundation has awarded more than 1600 grants to 514 organizations totaling nearly \$19M.



#### **Environment Program**

The Onion Foundation Environment Program aims to enable all Maine residents to enjoy the state's natural resources and to develop the knowledge, skills, and motivation to protect Maine's environment.

The Environment Program focuses its resources on the people of Maine, whose lives and behaviors will shape environment and climate change outcomes, rather than on capital investments and land acquisition.



### **Environment Program Strategies**

**STRATEGY 1: Equitable outdoor access** so that all Maine residents feel comfortable outside, connected to nature, and develop an ethic of care. **Open now! Deadline: 3/27/24.** 


**STRATEGY 2: Expand nature learning** that gives Maine residents the knowledge they need to take action in their communities.

Opens: 5/8/24. Info Session: 5/20/24.

**STRATEGY 3: Advocacy and movement-building** that enables Maine residents to protect the environment and mitigate the climate crisis.



Enable all Maine residents to enjoy the state's natural resources and to develop the knowledge, skills, and motivation to protect Maine's environment.



Increase access to the outdoors so that Maine residents are comfortable outside, feel connected to the natural world, and develop an ethic of care for nature

#### Priorities:

- A. Encourage Maine land trusts and watershed organizations to develop equitable organizations, inclusive programs, and easy access to the outdoors
- B. Eliminate barriers to accessing the outdoors confronted by underserved groups
- C. Support statewide or regional networks, initiatives, and infrastructure that strengthen and connect the outdoor access sector



**Priority A:** Encourage Maine land trusts and watershed organizations to develop equitable organizations, inclusive programs, and easy access to the outdoors

**Goal:** Land trusts and watershed organizations have the capacity and take steps to engage a diverse and growing number of Maine residents.

- Land trusts that have previously received OF support can now apply to the Land Trust Grant Fund Program at Momentum Conservation (Opens 4/10)
- Watershed and freshwater
   organizations that have previously
   received OF support will be invited
   to apply for grant funding, working
   directly with Susan.

**Priority B:** Eliminate barriers to accessing the outdoors and nature confronted by underserved groups.

**Goal:** Improve outdoor access for Black, Indigenous, and people of color and for people living with disabilities. The term "people living with disabilities" includes adults and children in Maine who identify as having mobility, cognition, independent living, hearing, vision and/or self-care disabilities (as defined by the CDC) and their families, friends, caregivers, and educators.



#### CALL FOR GRANT APPLICATIONS <u>OPEN NOW</u> UNTIL 3/27/24!

**Priority C:** Support catalytic statewide or regional networks, initiatives, and infrastructure resources that strengthen and connect the outdoor access sector.

**Goal:** Statewide and regional organizations increase learning, sharing, reach, efficacy, and efficiency among outdoor access organizations and reduce costs leading to a stronger sector.

# Eligibility

Types of Eligible Organizations:

- 501(c)(3) public charity
- Operating under a fiscal sponsor that is a 501(c)(3) public charity
- Public education institution
- Maine governmental unit

Must be based in Maine, focused on benefitting Maine's people, and meet the mission and priorities of the Onion Foundation. General operating support **OR** project/program-specific support

Check our <u>Environment Program</u> page FAQs to see which types of grants we generally do not fund.



### Eliminate Barriers Grant Program

- Grant range: \$5,000 \$30,000/year
- Grant term: up to two years
- Requests for two-year grants must describe two years of work with a two-year budget.
- Online submission deadline is Wednesday, 3/27/24 (notification in late May)
- Preview the <u>grant application</u> in Google Doc



### Eliminate Barriers Grant Program

#### Characteristics of a strong grant application:

- 1. Qualified leadership
- 2. People of color and/or people living with disabilities represented in the development and implementation of the work
- 3. Durable, relevant partnerships that support the participation of people of color and/or people living with disabilities

- 4. Thoughtful integration of the initiative into the community
- 5. Direct experiences with nature and the outdoors
- 6. Program design and communications that create a sense of belonging
- 7. Reduction of participant-specific barriers to participation



### Strategies 1 & 2 – What's the difference?

#### **STRATEGY 1: Equitable Outdoor Access – Eliminate Barriers**

- Focused on people of color and people living with disabilities
- Addressing barriers to people getting outside with the goal of **cultivating meaningful experiences in nature**
- Open now! Deadline 3/27/2024

#### **STRATEGY 2: Expand Nature Learning**

- Focused on school-aged Maine residents
- High-quality, natural systems-based, and experiential education programs, especially in underserved areas of the state
- Opening 5/8/2024



#### Eliminate Barriers Grant Program: Evaluation

- We carefully read all applications, and sometimes we reach out with questions.
- We consider the organization or program's potential to eliminate barriers for the priority groups.
- We consider how well each applicant meets those 7 characteristics.
- Other considerations: geographic diversity, overall impact on the sector, and how to fit as many awards to high-quality work as possible into our grantmaking budget.
